Dear parent or carer,

I hope my message finds you well.

I am writing to let you know that we are very excited to be welcoming all our pupils back to academy in the new term.

By being back amongst their teachers, we can continue to support our pupils' education and wellbeing, and help to support them in their recovery from any trauma, anxiety or loss they may have unfortunately experienced over the lockdown period.

However, we also understand that you may be concerned about the safety of your child as they prepare to return to a full academy. This may especially be the case for the parents of pupils who have been shielding or if you or someone in your household is concerned about their comparatively increased risk from COVID-19.

Whatever your concerns, please know that we will do everything we can to put the right support in place for you and your child.

All staff will wear a face covering while moving around the academy

We want all our pupils and staff to feel completely safe when in their academy, so whilst face coverings are at present only being recommended in secondary schools in areas where local restrictions are in place, our staff will be wearing a face covering when moving around the academy and in communal areas.

It will not usually be necessary to wear face coverings in the classroom, where protective measures already mean the risks are lower. However, our staff will be given the option to wear a visor in class so as to not inhibit communication between themselves and pupils.

Because of the lower transmission rate amongst children of a younger age and because there will be much less movement between classrooms, there is no requirement for primary pupils to wear a face covering. However, should a pupil feel more comfortable wearing one, they may of course do so and can bring one in to wear throughout the academy day.


Please keep in touch
